





2011 NHS BULLETIN: Income & Earnings

This report summarizes income and earnings data collected during the 2011 National Household Survey (NHS) for Wellington, Dufferin, and Guelph (WDG). Income data reported in this portion of the 2011 NHS was based on the year prior (2010). In 2010, 203,985 individuals in WDG, aged 15 and over, reported income. The average income (after-tax) was \$36,083.49.



Prevalence of Low Income in 2010 Based on LIM-AT




Did you know...
The Low Income Measure (LIM) identifies households with an after-tax (AT) income that is lower than 50% of the median national income for all families in that year. Living below this threshold is an indication of poverty.



2011 NHS BULLETIN: Education & Employment

This report summarizes education and employment data collected during the 2011 National Household Survey (NHS) for Wellington, Dufferin, and Guelph (WDG). In 2011, there were 139,980 individuals, aged 15 and over, who were employed in WDG. Overall, 61.4% of individuals, aged 25 to 64, in WDG have a postsecondary certificate, diploma or degree.






Highest Educational Level Achieved for Individuals Age 25 to 64



Gender Differences in Major Field of Study across WDG




National Occupation Classification (NOC) by Gender in WDG



Housing & Shelter

2011 NHS BULLETIN: Housing & Shelter

This report summarizes housing and shelter data collected during the 2011 National Household Survey for Wellington, Dufferin, and Guelph (WDG). In 2011, there were 99,145 occupied private dwellings in WDG; 76,915 (77.6%) of those dwellings were owned while 22,230 (22.4%) were rented. Overall, 7.2% of dwellings in WDG were constructed between 2006 and 2011.




Did you know...
 "Shelter costs" include monthly rent or mortgage payments, condo fees, and property taxes as well as the costs of electricity, heat, municipal services, etc.

Average Value of Dwellings




Percentage of Private Households in WDG by Suitability and Condition of Dwelling

Notes:

1. Median Renter Household Income = \$32,046
2. Median Renter Shelter Cost = \$850.00 monthly. Requires \$34,000 annually for affordability.
3. An average market rent for a two bedroom apartment was \$915* (per month) in 2013.

Half of the renter households in Peterborough have incomes below \$32,046 while 'affordable' income for an average market two-bedroom apartment is \$36,600 annually. More than 6,718 households have incomes below \$34,000 which is the 'affordable' annual income of the median renter shelter cost. From the renter household income distribution above, we know that many households are paying well in excess of 50% of their total household income ('severe core housing need').

The cost of housing becomes an impediment to healthy living when that cost precludes healthy eating, proper clothing or medical requirements. (Housing itself can present health hazards.) Housing-induced poverty is then realized. This is common when income levels are low or unsustainable.




Annual program work plan, 2014-2015

- Alpha-stage catalogue at communitydata.ca/catalogue2
 - Better metadata
 - Less complicated search filters
 - More sensible arrangement of geos
 - Pictures
- Easier to use than previous catalogue
- Still lots of work
 - Single-click downloads
 - Version française
 - Autocompleting search bar

- Shift in focus to:
 - Thematic guides
 - e.g. on working poverty, immigration, housing affordability
 - Technical tutorials
 - e.g. mapping taxfiler data, merging fields, Excel basics
- Specific themes and tutorials of interest?

4.3.2 ENVISION update

- From members' experience, we've found that ENVISION is
 - Not functional enough for power users who know GIS
 - Not intuitive enough for beginners who aren't familiar with data
- Four licenses in 2014-2015
- Only Census and NHS data available
- Vivianne (vivianne@communitydata.ca, vivianne@donneescommunautaires.ca) is available to help with ENVISION booking and general assistance
